**“Wavelength Music and Arts Festival”**...a full day of live Americana, folk, rock, indie music. Plus art installations and spectacle! In addition, WRHC will also host a beer tent, and a variety of merchandise and food vendors will participate. Wavelength is a fundraising event, benefiting WRHC-LP, a non-profit community radio station.

**Exhibit Days & Hours:** **Saturday July 31<sup>st</sup>, from 9am - 9pm ET (Music 11am-11pm)**  
Vendor space - outdoors in the parking lot of: **Dewey Cannon Park, Three Oaks, MI**

**Set up times:** Friday, July 30<sup>th</sup>, 5-8pm & Saturday, 8-9am. You will need to provide your own tables tents, display. It is advisable that you bring some form of cover for your goods as this is an open air event which will take place, rain or shine.

**Booth Information:** Booth spaces will be assigned according to logistical needs. Vendor spaces are approximately 10' x 10'. You may purchase more than one booth space if you need more room. Electricity and water access are limited.

**Parking:** You may unload your goods in front of your space and then vehicles must be moved to a designated area.

**Tents:** Tents must be provided by the vendors. Tents cannot be staked due to the asphalt parking lot. Therefore tents must have at least 50 lbs. of weight on each corner with cement, sand bags or water buckets to keep tent from blowing. If you do not weight your tent, you will be asked to disassemble it. You will also be liable for any damage your tent causes if not correctly weighted down.

**Tables:** Tables and chairs are the responsibility of each vendor, so bring whatever you need.

**Take down:** Vendors are responsible for take down and removal of all boxes, trash, etc.

**Liability:** WRHC-LP, Radio Harbor Country and the Village of Three Oaks, accept no responsibility for loss, damage or theft of merchandise.

**Cancellations:** Fees are non-refundable due to cancellations or no-shows.
